
1. Stonehenge - Indian Express

Borders:

West: Kenya and Ethiopia

o Northwest: Djibouti.

• **Terrain:** Arid plains, plateaus, highlands, and mountain ranges.


Relevance: Parliament and State Legislatures





6. Why govt has shelved draft Broadcast Bill - Indian Express

Relevance: Parliament and State Legislatures

Context

The Ministry of Information and Broadcasting recently withdrew a fresh draft of the Broadcast Bill which it had privately circulated among a handful of industry stakeholders. The draft had triggered widespread criticism from several quarters.

Reasons for withdrawal of the bill (Mains Analysis)

• **Difference of opinion within the ministry:** There were issues on whether the Bill should apply to non-news online content creators. As per the draft




Bill, such creators would have fallen under the category of OTT broadcasters.

Issues and confusion in the draft bill

- No mention of the 2024 draft.
- Secretive nature of consultations that the government engaged in: Consultations regarding the 2024 draft was held with only some industry bodies, telecom companies, and tech companies.

7. Why Delhi HC is hearing a plea against exclusion of IPC Sec 377 in BNS - Indian Express

Relevance: Structure, Organization and Functioning of the Executive and the Judiciary

Context

The Delhi High Court recently directed the Centre to clarify its stance on non-consensual sexual offences against LGBTQIA+ persons and men under the Bharatiya Nyaya Sanhita, 2023 (BNS). The new criminal law came into force on July 1, 2024, and replaced the Indian Penal Code, 1860 (IPC).



Chapter V of the BNS:

It provides the definition and punishment for rape under Section 63. However, the language of the section is gendered – it only considers rape in the context of a man committing the crime against a woman.

Section 377:

It severely punished non-consensual intercourse "with any man, woman or animal". Offenders could be punished with imprisonment for life and a fine.

Concerns surrounding the removal of Section 377 Provision in Bharatiya Nyaya Sanhita, 2023:

No provision for non-consensual sexual offence against male, female, transgender and for bestiality has been made.

Section 36: It provides every person with the "right of private defence"

to protect their own body or the body of another person "against any

offence affecting the human body". It also extends to protecting property from the offences of "theft, robbery, mischief or criminal trespass".

Alternative protections under the BNS

Section 38: It details the situations where this right allows the "voluntary causing of death or of any other harm to the assailant" which includes situations where a person is faced with "an assault with the intention of committing rape" or "an assault with the intention of gratifying unnatural lust".

Section 140: It punishes kidnapping or abduction where the victim is "subjected to grievous hurt, or slavery, or to the unnatural lust of any person". However, in both cases, "unnatural lust" has not been defined.


8. India to host third Voice of Global South virtual meet - The Hindu

Relevance: Bilateral, Regional and Global Groupings and Agreements involving India and/or affecting India's interests

Context

India will host the third Voice of Global South Summit in the virtual format on August 17 with a view to pitch for a sustainable future for the developing countries.

Voice of Global South Summit (VOGSS) in virtual format (Prelims)



Global South (Prelims)

- About: Encompasses diverse countries, drawing upon geopolitical, historical, and developmental factors. It broadly represents nations facing developmental challenges.
- Major countries:
 - **Countries in the northern hemisphere:** India, China and those in the northern half of Africa.



Countries in the southern hemisphere: Australia and New Zealand.

Brandt Line

- About: Proposed by former German Chancellor Willy Brandt in the 1980s as a visual depiction of the north-south divide based upon per-capita GDP.
- Symbolisation: It signifies the global economic divide, zigzagging across continents, encompassing parts of Africa, the Middle



East, India, and China, excluding Australia and New Zealand.

9. Al-Shabaab: growing from Somalia's ruins - The Hindu

Relevance: Effect of Policies and Politics of Developed and Developing Countries on India's interests, Indian Diaspora

Context

Recently, a suicide bomber detonated an explosive device at the entrance to the Beach View Hotel in Mogadishu, the capital of Somalia. Before the shock could

abate, five attackers stormed the site and started shooting at civilians indiscriminately.

Al-Shabaab (Prelims)

- **Literal meaning:** 'The Youth' in Arabic.
- Origin: A militant group preaching the Salafist version of Islam, had spread its roots in Somalia by seizing Mogadishu in 2006.
- Origin: Traced back to the al-Ittihad al-Islamiya (AIAI), a militant group that gained prominence



in the 1990s after the fall of Barre's regime.



- Members: Trained in West Asia and funded by the al-Qaeda.
- Sanctions: Banned by the United States and the United Kingdom.

Formation of Somalia (Mains Analysis)

- **7th 19th century:** Somalia and neighbouring regions were ruled by a series of Sultanates, with Islam's Sunni subsect being the primary religion.
- **19th century:** Colonial powers arrived, and the region was shared between British, Italian and French forces.
- **1960:** The British and Italian forces withdrew from the northern and southern regions & the two regions came together and formed modern-day Somalia.
- **1960 -69:** Democracy prevailed for a brief time until 1969 when Siad Barre came to power through a military coup.
- New administrative policy 'scientific socialism': Through it, Siad Barre nationalised banks and insurance companies, promoted literacy and strengthened ties with the Soviet Union.
- **1977:** The first signs of the authoritarian leader's downfall emerged with the Ogaden war that Somalia fought with Ethiopia in 1977.

Ogaden war/ Ethio-Somali War

- **Duration:** 12 July 1977 to 15 March 1978
- Parties: Ethiopia and Somalia
- Reason for the war: It was over the disputed region of Ogaden in which Ethiopia retaliated the Somalian invasion attempt of the region with the help mainly from Cuba and the USSR.
- Consequence: It resulted in the Ethiopian victory.




Relevance: Inclusive Growth and issues arising from it

12. PM- KUSUM - The Hindu

Relevance: Infrastructure: Energy, Ports, Roads, Airports, Railways etc

- Launch: 2019
- **About:** A scheme for de-dieselisation of the farm sector and enhancing the income of farmers.
- **Aim:** Adding Solar capacity of about 34,800 MW by March 2026 with the total Central Financial support of Rs 34,422 crore.
- Nodal Ministry: Ministry of New and Renewable Energy (MNRE)
- Provisions:
 - A central government subsidy upto 30% or 50% of the total cost is given for the installation of standalone solar pumps and also for the solarization of existing grid-connected agricultural pumps.
 - Farmers can also install grid-connected solar power plants up to 2MW, under the Scheme on their barren/fallow land.

13. Three more Ramsar wetland sites now in India, taking total to 85 - The Hindu

Relevance: Conservation, Environmental Pollution and Degradation

Context

The Environment Ministry recently said that three more wetlands in India have been designated 'Ramsar sites'. The three new sites are — the Nanjarayan Bird Sanctuary; the Kazhuveli Bird Sanctuary in Tamil Nadu; and the Tawa Reservoir in Madhya Pradesh.


India's Ramsar wetlands (Prelims)

- Area: Comprise around 10% of the total wetland area in the country across 18 States.
- Max. Ramsar sites: The United Kingdom (175) and Mexico (142)
- Largest area under Ramsar sites: Bolivia with 148,000 sq. km. under the Convention's protection.
- Largest Ramsar site in India: Sundarbans in West Bengal.

Wetlands

- **About:** Areas where water is the primary factor controlling the environment and the associated plant and animal life.
- Location: They occur where the water table is at or near the surface of the land, or where the land is covered by water.
- **Definition:** Lands transitional between terrestrial and aquatic eco-systems where the water table is usually at or near the surface or the land is covered by shallow water.

Ramsar Convention / 'Convention on Wetlands'





Ramsar site

- **About:** A wetland of international importance under the Ramsar Convention.
- Ramsar recognition: Identification of wetlands around the world, which
 are of international importance, especially if they provide habitat to
 waterfowl (about 180 species of birds).
- Criteria to be a Ramsar Site: (Mains Analysis)

Criterion 1:- The wetland must contain a representative, rare or unique example of natural or near natural wetland type found within the appropriate biogeographic region.

Criterion 2:- The wetland must support vulnerable, endangered, or critically endangered species or threatened ecological communities.

Criterion 3:- The wetland must support populations of plant and or animal species important to maintain the biodiversity of a particular biogeographic region.

Criterion 4:- The wetland must support plant and or animal species at a critical stage in their life cycles, or provides refuge during adverse conditions.

Criterion 5:- The wetland must support 20,000 or more waterbirds.

Criterion 6:- The wetland must regularly support 1% of the individuals in a population of one species or subspecies of waterbird.

Criterion 7:- The wetland must support a significant proportion of indigenous fish subspecies,.

Criterion 8:- The wetland must be an important source of food for fishes, spawning ground, nursery.

Criterion 9:- The wetland must support 1% of the individuals in a population of one species of wetland dependent non-avian animal species.

If a wetland of international importance is brought under the 'Montreux Record', what does it imply? (2014)

14. Namdapha National Park and Tiger Reserve - The Hindu

Relevance: Conservation, Environmental Pollution and Degradation

Context

- **Naming:** Namdapha is the name of a river originating in the park and it meets Noa-Dehing rive, a tributary of the Brahmaputra which flows in the middle of the National Park.
- **Climate:** Mountainous part has a mountain type of climate while the low-lying plains and valleys experience tropical climate.
- Location: Arunachal Pradesh
- **Coverage:** 1,985 sq km.



- **Location:** Situated near Indo-Myanmar-China trijunction between the Dapha bum range of the Mishmi Hills and the Patkai range.
- **Size:** Fourth largest national park in India after Hemis National Park in Ladakh, Desert National Park

in Rajasthan, and Gangotri National Park in

Uttarakhand.

• Establishment: 1983

 Vegetation: Tropical evergreen forests (Tropical Rain Forests)

Significance:

- The only park in the world to have the four Feline species of big
 - cat Tiger, Leopard, Snow Leopard and Clouded Leopard.
- It is also famous for Critically Endangered species like the Namdapha flying squirrel.
- Hoolock Gibbons, the only 'ape' species found in India is found in this National Park.




Relevance: Conservation, Environmental Pollution and Degradation

16. Biomass co-firing - Indian Express

Relevance: Science and Technology

- **About:** The practice of substituting a part of the fuel with biomass at coal thermal plants.
- Mechanism: Coal and biomass are combusted together in boilers that have been designed to burn coal. For this, the existing coal power plant has to be partly reconstructed and retrofitted.


• Significance:

- A globally accepted cost-effective method for decarbonising a coal fleet.
- An effective way to curb emissions from open burning of crop residue.
- Decarbonises the process of electricity generation using coal.

Challenges:

- Existing infrastructure is not robust enough yet.
- Seasonal availability and unreliable supply of biomass pellets to the utility.
- Storing biomass pellets for long durations at the plant sites.

17. Californium - Indian Express

Relevance: Science and Technology- Developments



- **About:** A silvery-white synthetic radioactive metal (very strong neutron emitter) with the atomic number 98 on the periodic table.
- Development: First made in 1950 at Berkeley, California
- **Usage:** In portable metal detectors for identifying gold and silver ores, to help identify water and oil layers in oil wells, and detect metal fatigue and stress in aeroplanes.
- **Cost:** It is highly radioactive and prohibitively expensive, with one gram costing Rs 17 crore in the international market.

18. Why latest mpox outbreak is 'emergency of international concern' - Indian Express

Relevance: Science and Technology- Developments

Context

The World Health Organisation, sounding its highest level of alarm, declared mpox as a Public Health Emergency of International Concern recently. This is the second time the infection has received the designation in as many years — the outbreak between July 2022 and May 2023 was also declared as PHEIC.




